

## **CONTEST RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

1. **Eligibility**  
PREMIUM BIKE GIVEAWAY (the "Contest") is open to legal residents of the fifty (50) United States of America and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Ground Control Systems and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries affiliates and advertising and promotion agencies as well as the immediate family and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.
2. **Sponsor**

3. **Agreement to Official Rules**  
Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with Official rules.
4. **Contest Period**  
The Contest begins on Thursday, April 20, 2017 at 6 am and ends on June 1, 2017 at 12:01 am ("the Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods: text message, email, business card submission.
5. **How to Enter**  
Limit one (1) entry per person, per email address, per text message, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, email address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor.
6. **Prize Drawing**  
On or about June 1, 2017, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about June 1, 2017. If the potential winner cannot be contacted within ten (10) days after the date of the first attempt to contact them, the Sponsor may select an alternate potential winner in their place at random from the remaining, non-winning eligible entries.
7. **Winner Notification**  
The potential winners will be notified by phone, email or mail. Each potential winner will be required to complete and return a Declaration of Compliance in order to receive prize.
8. **Prize**  
The prize will be one, custom-built road bike with a Shimano Ultegra 6800 drive train and Mavic Aksium 11 speed wheels. The Prize retails for over \$3,000
9. **General Conditions**  
In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to, fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the even the Contest is unable to run as planned for any other reason as determined by Sponsor in its sole discretion, the Sponsor may in its sole discretion either suspend the Contest to address the impediment and then resume the Contest in conformity with the rules, or

terminate the contest, and in the event of termination award the prize at random from among the eligible entries received up to the time of impairment. The Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or operation of the Contest or to be acting in violation of the Official Rules or in any unsportsmanlike or disruptive manner. Any attempt by any person to undermine operation of the Contest may be in violation of criminal and civil law, and should Sponsor choose, Sponsor reserves the right to seek damages, including attorney's fees, and any other justified remedies to the full extent of the law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

#### 10. Release and Limitations of Liability

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, employees, shareholders, representative and agents (the Released Parties) from and again any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or related activities) including but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable internet service provider network, server, wireless service provider, or other connections, availability or accessibility or miscommunications of failed computer, satellite, telephone, cellular tower or cable transmission, lines or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) any other problems in connection with the Contest, including, without limitation. Errors that may occur in the administration of the contest, the announcement of the winner, the cancellation or postponement of the event or any contest-related material; or (e) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Contest, and in no event shall the entrant be entitled to receive attorneys' fees. Released Parties also are not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive consequential, direct, or indirect damages.

#### 11. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of or connected with the contest or any prize awarded shall be resolved individually, without resort to any form of action, and exclusively by the appropriate court located in Sacramento, California. All issues and questions concerning the construction, validity, interpretation and enforceability of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of California, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than California.
